## Welcome

- Schools met at the airport? **Thanyapura or volunteer staff will meet schools with clearly identifiable signage**
- Transport from Airport to Hotels? **Local bus company to provide. Safety checks on file**

## Thanyapura / HOMA Hotel

- Who will be on site? **Teems Representatives; Event staff Team Staff/Coaches; Resort Resort staff; Participant Parents**
- Lanyards for coaches, teachers, parents etc? **Thanyapura to provide sticker/wristband to identify parents**
- Suitable parking? **Sufficient parking space is available**

## Accommodation

- Balconies - **will be locked at all times**
- Locks on doors/toilets/showers - **will be checked prior to check in**
- Glass tables/bottles in the rooms? **Will be removed**
- Schools grouped together
- Separate sexes - **Girls & boys will be on separated**
- Teacher/Coach posted nearby and signposted on their doors

## Swimming

- Event Schedule? Times between races; waiting around etc; schools travelling from hotel off-site; **Teems to provide 2/3 months before tournament; will be member checked to spot clashes/omissions etc**
- Format - Same as last years event and as per the website meet information **TASA regulations will be followed**
- officials / Timekeepers - **They will be briefed and have previous experience at a TSA event - DQ and Appeal system communicated in advance**

- Shade - **Shade/seating area provided around the pools**
- Water stations. ; **Positioned around Thanyapura**
- Transport between venues? **Timetables and allocated buses per school. Shared and checked with each school in advance**
- Thnayapura maps? **Will be created and displayed around the site and shared beforehand**
- 'School Zones' signposted and numbered? **Included on Map and shared prior to the event plus available on site.**

## Coaches/Teachers

- Coaches room for briefing - **Yes a daily briefing will be provided**
- Food/snacks? - **Not necessary; Catering is full board. Food vendors also positioned around the pitches**
